#### 5. RESERVATION AND RELATED INFORMATION:-

- a) The number of vacancies advertised is only an indicative number and is liable for change (decrease or increase) with reference to vacancy position at any time before finalization of selection for appointment.
- b) The rule of reservation is applicable as per the rules in force. Detailed instructions with regard to reservation can be seen in Annexure-2 and 3 of this notification.
- Classes is applicable only to Backward Class Muslims (BCMs). All the concessions/relaxations / benefits applicable to BC candidates are applicable to BC Muslim candidates as well.
- d) The expression B.C (i.e. Backward Class) wherever it occurs including online application form, should be read as "B.C. (other than Muslims) and [BCMs denotes Backward Class Muslims].

# e) Reservation for Ex-servicemen:-

In direct recruitment to the Group "C" post, five percent (5%) posts are reserved for Ex-servicemen as per the 200 point roster of Government of Tamil Nadu. Every candidate claiming to be an Ex-servicemen, if already discharged, should produce the Discharge Certificate from the Defence services, pension, payment order etc. and if the candidate is a serving personnel (yet to be discharged) the candidate has to produce an undertaking as **in Annexure 8 A** (in Annexure — 8) and form of certificate for serving personnel **in Annexure 8 B** (in Annexure — 8).

# f) Person Studied in Tamil Medium (PSTM)

Section 2 (d) of the Tamil Nadu Appointment on Preferential Basis in the Services under the State of Persons Studied in Tamil Medium (Amendment) Act, 2020, states that 'Person studied in Tamil medium means a person who has studied through Tamil medium of instruction upto the educational qualification prescribed for direct recruitment in the rules or regulations or orders applicable to any appointment in the services under the State".

g) Reservation for differently abled:-

Provision of Tamil Nadu Government Servant (Conditions of Service) Amendment Act 2016 (Act 30 of 2017) will be applicable.

4% of the posts are reserved for Differently Abled candidates with bench mark disabilities as per G.O.(Ms.) No. 21, Welfare of Differently Abled Persons (DAP-3.2) Department dated 30.05.2017. The Details of Disabilities suitable as per G.O.(Ms).No.9, Welfare of Differently Abled Persons (DAP-3.2) Department, Dated: 23.03.2023 and G.O.(Ms).No.20, Welfare of Differently Abled Persons (DAP-3.2) Department, Dated: 26.09.2025 for LD (OL, Others), AC (With mobility), LC (With mobility), DF, SLD and MD. That Certificate should be obtained from the Medical Board of a Government Medical college.

#### **Explanation:**

No Maximum age limit shall mean that the applicants should not have completed 60 years of age on the date of Notification OR at the time of selection / appointment to the post.

#### Note:

 Applicants not belonging to SCs, SC(A)s, STs, MBC&DNCs, BCs, BCMs who have put in 5 years or more of service in the State/Central Government are not eligible to apply even if they are within the age limit.

#### Age concession for Ex-servicemen:-

- 1. "Persons serving in the Armed Forces shall be eligible to apply for posts under the Government if they are due to Complete the specified term of their engagement in the Armed forces within one year from the last date prescribed by the appropriate authority for receipt of the application in respect of a particular recruitment. All such candidates while making their applications shall submit a self undertaking and a form of certificate from their Commanding Officer in the format given in Annexure 8 of thisnotification."
  - [Section 63 of Tamil Nadu Government Servants (Conditions of Service) Act 2016]
- 2. The age concession will not apply to the Ex- servicemen applicants who have already been recruited to any class or service or category. (Section 3(j) of the Tamil Nadu Government Servants (Condition of Service) Act 2016.

#### **6B. EDUCATIONAL QUALIFICATION:-**

Candidate shall possess the following qualification as per G.O (Ms).No.104, Health and Family Welfare (L1) Department, Dated:28.03.2023 on the date of this notification viz. 27.10.2025.

- I. Must have passed plus two with Biology or Botany and Zoology.
- II. Must have passed Tamil Language as a subject in S.S.L.C Level
- III. Must possess Two years Multipurpose Health Worker (Male) / Health Inspector/ Sanitary Inspector Course Certificate granted by the Director of Public Health and Preventive Medicine:

"Provided that those who possess the one year the Multipurpose Health Worker (Male) training course certificate granted by the Director of Public Health and Preventive Medicine conducted in the Government training Centre or Institutions approved by the Director of Public Health and Preventive Medicine, prior to the introduction of the two years Multipurpose Health Worker (Male) / Health Inspector/ Sanitary Inspector Course Certificate granted by the Director of Public Health and Preventive Medicine, are also eligible for appointment to the said post."

As per one time Measure Relaxation ordered in G.O.(Ms).No.443, Health and Family Welfare (L1) Department Dated: 14.10.2025 all eligible applicants who have passed one year course certificate (Must possess one year Multipurpose Health Worker (Male) course / Sanitary Inspector Course in University affiliated / Government recognized institutions. The syllabus followed in such institutions should be equivalent to the syllabus prescribed by the Director of Public Health and Preventive Medicine vide G.O(Ms).No.338, Health and Family Welfare (L1) Department, Dated:02.08.2019) from those University / Institute which received equivalent certificate so as to participate in the recruitment process as one time measure as per G.O (Ms).No.338, Health and Family Welfare (L1) Department, Dated:02.08.2019.

Note:

- 1. Candidates possessing the above qualifications on the date of notification alone shall apply for this post.
- 2. If a candidate claims that the educational qualification possessed by him is equivalent though not the same as those prescribed in this notification, the onus of the proof rests with the candidate.

#### 6 C. CITIZENSHIP:-

That he is -

- (i) A citizen of India; or
- (ii) A subject of Nepal or Bhutan; or
- (iii) A person of Indian Origin who has migrated form Pakistan, Burma, Sri Lanka, Vietnam, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tank Anika and Zanzibar) Zambia, Malawi, Zaire and Ethiopia with the intention of permanently settling in India.
- (iv) An applicant belonging to categories (iii) or a subject of Nepal or Bhutan should also obtain a certificate of eligibility given by the Government of Tamil Nadu.

(v) An applicant in whose case a certificate of eligibility is necessary will be admitted to an examination or interview and he will provisionally be appointed subject to the necessary certificate being given to him by the Government of Tamil Nadu

#### **6 D. CONDITIONS AND QUALIFICATION:-**

- a. The claims of the candidates with regard to the date of birth, educational/technical qualifications and community are accepted only on the information furnished by them in their on-line application without physical verification of their claims. Their candidature, therefore will be provisional and subject to the Board satisfying itself, about their age, educational/technical qualifications, community etc. The candidature, is therefore, provisional at all stages and the Board reserves the right to reject any candidature at any stage, even after the selection has been made.
- b. Candidates who consider themselves eligible to appear in the written examination may apply and write the examination at their own risk, with an undertaking/declaration to that effect viz. before appearing for the examination, it should be ensured by the candidate that on the date of Notification of a post he fulfils all the conditions in regard to age, educational qualifications, etc. as provided in the rules. The candidature of candidates, if found ineligible shall stand cancelled, even after declaration of the result.
- c. Candidate shall not have any adverse character or antecedents.
- d. Candidate shall not have more than a living spouse
- e. Candidates already working in Government or Public Sector Undertaking or Local Bodies shall produce a No Objection Certificate, as in Annexure-5 of this Notification, from their appointing authority, at the time of certificate verification (if provisionally selected)
- f. The Differently Abled persons should submit copy of Differently Abled Certificate specifying the nature of physical handicap and the degree of disability when called for by the Medical Services Recruitment Board. If selected, they should produce a Fitness Certificate obtained from the Medical Board as mentioned in Annexure-7 of this Notification. [Section 20 (5) of Tamil Nadu Government Servants (Conditions of Service) Act 2016]
- g. If a candidate claims equivalent Qualification the onus of providing the same rests with the candidate.
- h. The selection for appointment to the above said post is purely provisional subject to final Orders on pending Writ Petitions, if any, filed at Madras High Court and Madurai Bench of Madras High Court.

#### Note:-

- The Subject Question paper will be set in Tamil and English only and will contain 100 objective type questions. (For syllabus Refer Annexure – 11 of the Detailed instructions)
- 2. There will be no negative mark for the wrong answer.
- The Questions will be in the standard of Certificate Course Level.

#### 7a) Normalization of the marks:-

The Computer Based Examination is conducted in multiple sessions. Whenever Computer Based Examination is conducted in multiple sessions based on the same syllabus, same pattern, for candidates having same eligibility criteria, the raw marks obtained by the candidate in different sessions will be converted to normalized marks. A candidate will be permitted to appear only in one session. Attending more than one session will automatically lead to disqualification of the candidates and no further correspondence in this regard will be entertained.

In case the examinations are conducted in only one session, actual marks obtained by the candidate will only be considered for calculating the Merit List.

#### **Calculation of Normalization marks for multi-sessions papers:**

In case of multi-sessions paper, a suitable normalization is applied to take in to account any variation in the difficulty levels of the questions paper across different sessions. The following Normalization formula for calculating the normalized marks for the multi-session paper is adopted as followed in various Competitive Examination in India

Score Normalization using Mean and Standard Deviation of Base Standard and Target Batch,

In this method there are following 3 factors:

- A) Ratio of SD of Base/ Standard Batch to SD of Targeted Batch.
- B) Difference of Score of Candidates and Average Score of the Target Batch.
- C) Average Score of Base / Standard Batch Normalized Score = A\*B+C

Batch with maximum average with minimum 70% of the overall average attendance is considered as the Base/Standard Batch.

#### 7b) COVID DUTY - Incentive Marks:

Government in their G.O.(Ms).No.299 Health and Family Welfare (C1) Department, Dated: 12.09.2023 and G.O.(Ms).No. 382 Health and Family Welfare (L1) Department, Dated: 08.12.2023 issued orders for awarding incentive marks to Health Inspector Grade II, who have rendered their services during covid-19 crisis in the Government Medical institutions and otherwise qualified in the Tamil Eligibility Test in addition to the marks obtained by them in the examination conducted by Medical Services Recruitment Board for the post of Health Inspector Grade II and the incentive marks will be awarded as detailed below:

Government in their G.O.(Ms)No. 299 Health and Family Welfare (L1) Department, Dated: 12.09.2023 and G.O.(Ms)No. 382 Health and Family Welfare (L1) Department, Dated: 08.12.2023 issued orders for awarding incentive marks to the Health Inspector Grade – II ,The following conditions has to be satisfied by the Health Inspector Grade – II to claim the above incentive marks.

- a) The Incentive marks shall be awarded only to the candidates who have successfully applied for the post of Health Inspector Grade-II as per the Notification (No.16/MRB/2025 Dated:27.10.2025) possessing the prescribed educational qualification as para 6(B) of the Notification.
- b) The Incentive marks are awarded to the candidates as a one time measure and not eligible to the candidates for successive recruitments.
- c) The incentive marks will be eligible to only one recruitment which is being done after covid - 19 Pandemic situation.
- d) The above incentive marks shall be based on the Covid Duty Certificate (Annexure 10) furnished by the candidates and the same has to be uploaded in the online portal alone on or before 16.11.2025 and to be submitted in original during Certificate Verification
- e) The candidates should have worked in Urban/ Rural/Local Body / local body run Covid Care centre / Covid health center etc., / Medical Colleges

- /\* Government Institutions (Hospitals, Primary Health Centres/ Health sub Centre during COVID PANDEMIC period.
- f) The Covid Duty Certificate ( Annexure 10) shall be issued by the concerned authorities to the candidates based on the attendance in the Government Medical Institutions.

## **8. CENTER FOR EXAMINATION;**

- I) Examination will be conducted in one or more of the centers in all the 38 districts (Tentatively). The Board reserves the right to increase or decrease the number of examination centers depending on administrative exigencies.
- II) Candidates should appear for the Examination at their own expenses and no TA/DA will be paid.

#### 9.PROCEDURE OF SELECTION:-

1) Candidates should undergo the Tamil Eligibility Test (SSLC Standard) in any of the sessions decided by the Board on the day of the Computer Based Test Examination (CBT) for the post of Health Inspector - II. Marks secured in the Tamil Eligibility test (S.S.L.C Standard) will not be taken into account for ranking. Candidates those who have qualified in Tamil Eligibility Test (S.S.L.C

- Standard) by obtaining minimum qualifying marks of 40 % alone are eligible for corrections of the subject paper prescribed for this post.
- 2) Selection will be made based on the marks obtained in the Computer Based Test in the subject paper and the incentive marks awarded for the services rendered during Covid-19 pandemic, and duly following the rules of reservation and communal rotation of Government of Tami Nadu and other conditions stipulated in this notification.
- 3) Short listed candidates will be called for verification of the original certificates as claimed in their on-line application form (as detailed in Annexure 3 of this Notification)
- 4) There will be No Oral Test for the post.



#### 11. ON-LINE REGISTRATION:

- a. Interested and eligible candidates are to visit the Medical Services Recruitment Board's website https:/www.mrb.tn.gov.in and familiarize themselves with the detailed notification.
- b. On the Home Page, click "Online Registration" to open up the On-Line Application Form.
- c. Select the name of the post of Health Inspector Grade-II.
- d. All the required particulars be entered without skipping any field.
- e. Mobile number and e-mail is mandatory; you are also requested to provide alternate secondary Mobile No., Landline number as well. All communication from MRB will be sent only to the registered primary mobile number by SMS and to the registered e-mail ID only

#### and by no other means.

f. Candidates are required to upload the scanned copy of their colour photograph and scanned copy of their signature as per the specifications given in the Guidelines for Scanning and Upload of Photograph and Signature. An online application is incomplete without the Photograph, and Signature upload.



- g. The candidates need to apply only in online mode. They shall not send copies of certificates / printed application to MRB. In the online application, candidates need to furnish the details such as: Community Certificate number; Issuing Authority; Date of issue, in support of the claims made with regard to community failing which the application will not be considered.
- h. Evidence for all the claims made in the online application should be uploaded at the time of submission of online application. Any subsequent claim made after submission of online application will not be entertained. Failure to upload the documents at the time of submission of online application will entail rejection of application after due process.
- i. Incomplete applications and applications containing wrong claims or incorrect particulars relating to category of reservation / eligibility / age / gender / communal category / educational qualification / medium of instruction /
  - physical qualification other basic qualifications and other basic eligibility criteria will be summarily rejected after due process.
- j. Candidates need to verify their eligibility for the post before submitting their online application. If a candidate furnished wrong information, action will be taken by MRB to debar such candidate from the future exams/recruitment, apart from other legal actions.

#### 13.CERTIFICATE OF PHYSICAL FITNESS:-

Candidates provisionally selected for appointment to the posts will be required to produce a certificate of physical fitness including Vision Certificate in the prescribed form.

#### 14.SPECIAL INSTRUCTIONS:-

All the candidates wishing to apply shall abide by / agree to the following undertaking and declaration in the on-line application form. In addition, candidates who are called for certificate verification shall also submit the following undertaking and declaration.
